## About our speaker

Gill is a Consultant Forensic Psychiatrist at Rampton Hospital. She has been employed by Nottinghamshire Healthcare NHS Foundation Trust since 2010. In this role she works within a multi-disciplinary team providing highly specialist assessment and treatment of patients with personality disorders. Gill previously worked as a visiting psychiatrist at HMPs Lowdham Grange, Nottingham and Lincoln. She also worked at HMP Foston Hall as a volunteer psychodynamic interpersonal therapist for the WORSHIP II (Women Offenders Self Harm Intervention Pilot II) study. Gill worked in Arnold Lodge (medium secure unit, male mental illness directorate and male personality disorder service) and at the Wells Road Centre (low secure women's service). She has also worked with forensic patients in the community in Nottinghamshire.

Becky advised the Department of Health in relation to their online training package on the Mental Capacity Act rolled out to over 1.5 million NHS staff, represented the acute Trust in the first MCA case heard by the Supreme Court (Aintree University Hospital Trust v J [2013]), and is well known for her expertise in the area of consent, capacity and best interests. Becky is regularly involved in high-profile, complex reported cases, such as the case of Devon Partnership NHS Trust v SSHSC [2021] and [2023] UKUT 195 (AAC) PQR v Derbyshire Healthcare NHS Foundation Trust concerning the legality of remote Mental Health Act assessments during the COVID 19 pandemic.
